LIABILITY WAIVER, RELEASE, INDEMNITY AGREEMENT,
ASSUMPTION OF RISK AGREEMENT AND USE OF IMAGE AGREEMENT**

I _____ (“Participant”), in consideration of being allowed to participate in flying RC model aircraft at King Ranch (APN 181-120-060, 181-120-070, 182-070-050 and 182-080-040, Solano County, California, the titles of which are held by the Solano Land Trust), racing events, related events, activities, and use of the slope, roads and adjacent areas (hereinafter collectively the “Event”), for myself, my spouse, and our respective heirs, successors, assigns, agents, and administrators do HEREBY RELEASE, WAIVE, DISCHARGE, INDEMNIFY, AND HOLD HARMLESS Norcal Slope Soarers Inc. and the Solano Land Trust, and their respective members, directors, boards, employees, agents, subcontractors, officers, owners, affiliates, related companies, and governing bodies (referred to hereinafter collectively for all purposes as “Releasees”) of and from any and all demands, actions, causes of action, claims of any kind or nature whatsoever, known and unknown, anticipated or unanticipated, past or present, which may be initiated by Participant, my spouse, and our respective heirs, successors, assigns, agents, and administrators or by any other person or organization on Participant’s behalf, arising from or related to a claim for injuries and damages which is alleged to have been caused in whole or in part by the negligence or acts of the Releasees, the public, spectators, volunteers, referees, judges, and/or other participants 1) which may exist arising out of or related to the participation in the Event sponsored, managed, and/or operated by Releasees and/or 2) in connection with or relating to any property and/or equipment owned, maintained and/or operated by Releasees in connection with the Event.

I fully understand and acknowledge that 1) flying and racing RC (radio-controlled) gliders can be an inherently dangerous sport, which may result in injury, disability, paralysis, or death; 2) there are risks and dangers inherent and/or associated with the participation in the events and activities related to Event that no amount of care, caution, instruction, or expertise can eliminate; 3) the social and economic losses and/or damages which could result from these risks and dangers described above, could be severe; 4) these risks and dangers may be caused by the action, inaction, or negligence of the participant or the action, inaction, or negligence of others, including but not limited to the Releasees named herein; and 5) there may be other risks not known to me or is not reasonably foreseeable at this time.

I expressly ACCEPT AND ASSUME SUCH RISKS AND RESPONSIBILITY for the losses and/or damages following such injury, disability, paralysis, or death, however caused and whether caused in whole or in part by the acts or failure to act and/or negligence of the Releasees named herein.

I further agree that I WILL NOT SUE OR MAKE A CLAIM against Releasees for losses and/or damages sustained as a result of my participation in Event including but not limited to RC model aircraft activities.

I further grant permission to Releasees to use my image or likeness appearing in any photographs, videotape, motion picture, or any other media, related to the Event, for any of Releasees’ advertising or promotional purposes whatsoever, in perpetuity throughout the world.

I HAVE READ THIS WAIVER OF LIABILITY, RELEASE AND INDEMNITY AGREEMENT AND ASSUMPTION OF RISK AND FULLY UNDERSTAND ITS TERMS. I EXPRESSLY ACKNOWLEDGE THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO ME. I INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
