

**INTERNATIONAL SLOPE RACE LIABILITY WAIVER, RELEASE,  
INDEMNITY, ASSUMPTION OF RISK AND USE OF IMAGE AGREEMENT**

I \_\_\_\_\_ ("Participant"), in consideration of being allowed to participate in, volunteer at, or observe flying model aircraft at or around the Las Trancas Airport, 3564 CA-Highway 1, Davenport, CA 95017 including racing events, practice events, related events, activities, and use of the slope, roads and adjacent areas (hereinafter collectively the "Event"), for myself, my spouse, my children and our respective heirs, successors, assigns, agents, and administrators ("Representatives") do HEREBY RELEASE, WAIVE, DISCHARGE, INDEMNIFY, AND HOLD HARMLESS Norcal Slope Soarers Inc., Aloft Hobbies, Big Creek Lumber, Big Creek Timber, The Recreational Aviation Foundation, International Slope Race organizers and their respective members, directors, boards, employees, agents, subcontractors, officers, owners, affiliates, related companies, and governing bodies (referred to hereinafter collectively for all purposes as "Releasees") of and from any and all demands, actions, causes of action, claims of any kind or nature whatsoever, known and unknown, anticipated or unanticipated, past or present, which may be initiated by Participant, or my Representatives or by any other person or organization on Participant's behalf, arising from or related to a claim for injuries and damages which is alleged to have been caused in whole or in part by the negligence or acts of the Releasees, the public, spectators, volunteers, contest directors, judges, and/or other participants which may exist arising out of or related to the participation in the Event sponsored, managed, and/or operated by Releasees and/or in connection with or relating to any property and/or equipment owned, maintained and/or operated by Releasees in connection with the Event.

I fully understand and acknowledge that (1) flying and racing RC (radio-controlled) gliders can be an inherently dangerous sport, which may result in injury, disability, paralysis, or death; (2) there are risks and dangers inherent and/or associated with the participation in the events and activities related to Event that no amount of care, caution, instruction, or expertise can eliminate; (3) the social and economic losses and/or damages which could result from these risks and dangers described above could be severe; (4) these risks and dangers may be caused by the action, inaction, or negligence of the participant or the action, inaction, or negligence of others, including but not limited to the Releasees named herein; and (5) there may be other risks not known to me or not reasonably foreseeable at this time. These risks include, but are not limited to, (a) being struck by an aircraft flying on or near the race course, where such aircraft may be under the control of a pilot or may be out-of-control due to pilot error, aircraft failure, failure of radio components such as batteries, transmitters, receivers and servos, and (b) slip and falls in and around the Event while racing, flying, retrieving aircraft, volunteering, moving and constructing Event equipment, or observing the Event.

I expressly ACCEPT AND ASSUME SUCH RISKS AND RESPONSIBILITY for the losses and/or damages following such injury, disability, paralysis, or death, however caused and whether caused in whole or in part by the acts or failure to act and/or negligence of the Releasees named herein.

I further agree that I AND MY REPRESENTATIVES WILL NOT SUE OR MAKE A CLAIM against Releasees for losses and/or damages sustained as a result of my participation in Event including but not limited to RC model aircraft activities.

I further grant permission to Releasees to use my image or likeness appearing in any photographs, videotape, motion picture, or any other media, related to the Event, for any purposes whatsoever, in perpetuity throughout the world.

Failure to enforce any provision of this Agreement will not constitute a waiver. If any part of this Agreement is held unenforceable, the validity of all remaining parts will not be affected. This Agreement is governed by the laws of the State of California (excluding its conflict of law rules) and the federal laws of the United States. The state and federal courts located in California will be the exclusive jurisdiction for all disputes arising out of or in connection with this Agreement, and the parties hereby consent to personal jurisdiction thereof. This Agreement contains the entire agreement of the parties with respect to the subject matter hereof and supersedes all previous or contemporaneous communications, representations, understandings and agreements, whether written or oral, between the parties regarding the subject matter hereof.

I ACKNOWLEDGE THAT I WAIVE SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO ME OTHER THAN EXPRESSLY STATED HEREIN. I INTEND THIS TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.**
